The purpose for collecting and processing personal data	Personal data is collected and processed in order to implement the communications of research network activities, to organize network meetings and other events of the research network (e.g. conferences, seminars, training). We will process your data, if you have joined the network by filling and submitting the network registration form. Your data is also processed when you have signed up for events organized by the network (e.g. network meetings and conferences).
The legal basis for data processing	The data subject has given consent to the processing of their personal data. You have the right to withdraw the consent at any time. You can easily cancel your consent by sending an email to the contact person.
What personal data do we process?	We process the following data: <ul style="list-style-type: none">• Name• Contact details• Affiliation/employer/university• Title/profession• Education• Research interests / research topics

	<ul style="list-style-type: none"> • Publications <p>All personal data is derived from the data subject, who has filled and submitted a network registration form, or signed up for events organized by the network (e.g. network meetings and conferences).</p>
For how long will your data be processed?	<p>The data is processed for the duration of the Nordic Arts & Health Research Network project.</p> <p>Your personal data will be deleted upon your request.</p>
Who will have access to your data?	<p>Your personal data is processed by the Nordic Arts & Health Research Network project team. In addition, the TUAS IT services will process your data (name + email address) when administrating the mailing list.</p>
Data transfer	<p>Your personal data is not transferred to third parties.</p> <p>Your personal data will not be transferred outside the EU/EEA area.</p>
Description of the technical and organizational safety measures.	<p>TUAS as a data controller will take appropriate technical and organisational measures against unauthorised or unlawful processing of personal data and against accidental loss or damage to personal data.</p> <p>Access to your personal data is limited with user IDs and access rights.</p>
Your rights as a data subject	<p>As a data subject, you have the following rights:</p> <ul style="list-style-type: none"> • Right to access • Right to rectification (remember to keep your contact information up to date) • Right to erasure ('right to be forgotten') in some cases • Right to the restriction of processing in some cases • The right to object to the processing • Right to be informed of any information security breaches causing a major risk • Right to lodge a complaint with a supervisory authority <p>If you have any questions about your rights, you can contact the University's Data Protection Officer or the contact person of the database concerned.</p>
